- Civil Society Organizations (CSOs) engaged in social protection

Status of the National Social Protection Policy

01

The process of updating Liberia's National Social Protection Policy and Strategy is currently underway, led by the Ministry of Gender, Children and Social Protection (MoGCSP) with support from the REALISE project and it's donors

02

Capacity-building sessions for MoGCSP staff are ongoing to ensure effective policy updating, alignment with national priorities, and global best practices.

03

Consultations with key stakeholders, including government agencies, development partners, and civil society, will be conducted to ensure inclusivity and ownership.

A technical review of the draft NSPP is planned to ensure alignment with the National Agenda and Sustainable Development Goals (SDGs), particularly SDG 1.3 on social protection coverage.

Forming technical working groups (TWGs) is essential for fostering effective collaboration, coordination, and implementation of social protection programs. These groups serve as specialized platforms, bringing together experts, stakeholders, and practitioners to address specific technical aspects of program design, delivery, and evaluation.

In the context of Liberia's social protection landscape, TWGs are critical for advancing initiatives such as the Social Registry, Cash Transfer targeting, monitoring and evaluation frameworks, and the integration of social protection with other sectors like health, education, and agriculture, ensuring that interventions effectively reach the most vulnerable populations.
